Tips from the Tower

Hot Spots: On November 15th the FAA published an Airport Diagram for San Luis Obispo Airport including “hot spots” for the first time.

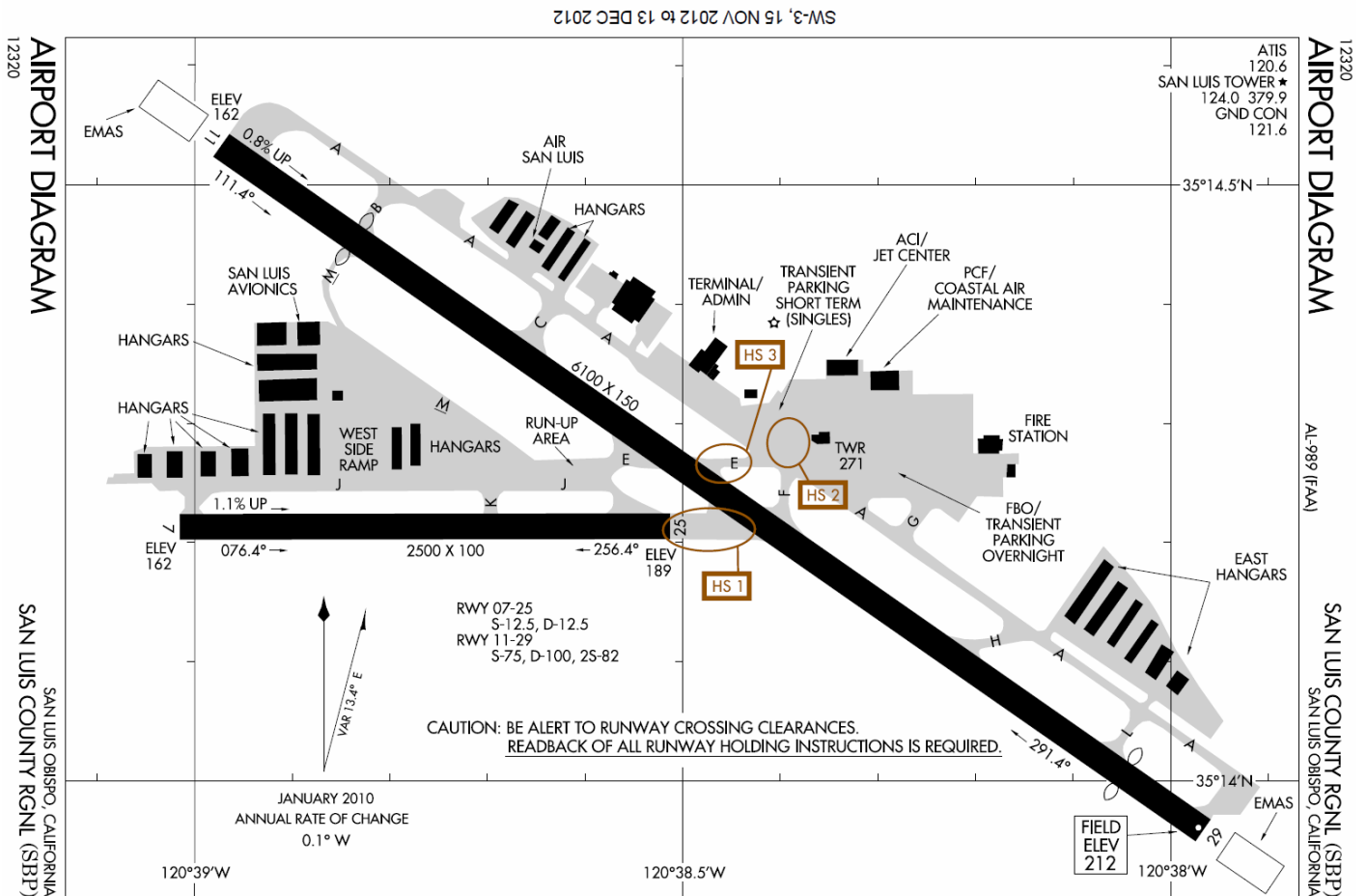
A “hot spot” is a runway safety related problem area or intersection on an airport. Typically it is a complex or confusing taxiway/taxiway or taxiway /runway intersection. A confusing condition may be compounded by a miscommunication between a controller and a pilot, and may cause an aircraft separation standard to be compromised. The area may have a history of surface incidents or the potential for surface incidents.

This may be due to any mix of causes:

- Airport geometry
- Ground traffic flow
- Markings, signage, or lighting
- Human factors

If you should be aware of any locations on an airport that warrant extreme caution because of complex airport geometry and/or potential pilot disorientation, do not hesitate to inform airport or air traffic management. We need your participation to reduce airport surface incidents, particularly runway incursions. Report:

- Confusing pavement intersections
- Unclear pavement markings or lighting
- Perplexing/absent signage
- Distracting airport conditions
- Confusing air traffic procedures and communications
